**DIRECTIONS:**

**From Route 80 East or West (exit 27A) to Route 206 South:** Go 4 miles, turn right onto Bartley Road, just before the railroad overpass. Go about a mile to Top Dog on the right.

**From Route 287 (exit 22B) to Route 206 North:** Take 206 through the town of Chester and cross the intersection of 206 and 24/513. Stay on 206 to the second traffic light and make a left onto Bartley-Chester Road. Cross over the railroad tracks. Turn right and then make an immediate left to Top Dog.

*Please note:* GPS directions leave you short of the destination by a mile or so.

**HOTELS AND MOTELS that accept dogs:** As hotels may change policies and fees, be sure to ask when you reserve a room. Facilities are listed in order of estimated driving time from the show site. Non-refundable fees for a pet are listed. There is free parking at the event site for RVs; however, there are no hookups available.
